Brian – District Report

- Dana Millsap- 95-2014-005-14 RFP- Brian went out and the road looks good requesting payment of \$12,933 to complete this contract.
  - Angela Gragg made a motion to approve the RFP in the amount of \$12,933 to complete the contract # 95-2014-005-14. Al Childers seconded; all were in favor.
- Paul Gragg- 95-2015-001-14- Brian has received approval and is going to schedule a preconstruction meeting with Paul.

ACSP- 2 permanent cattle and goat drinkers, 3 temporary drinkers, pasture rotations Al Childers made a motion to approve the application for AgWRAP. Angela Gragg seconded; all were in favor.

AL Childers made a motion to approve the application for ACSP. Joey Clawson seconded; all were in favor.

- Charles Norris- ACSP- Brian is going over Lidar data and access road rules pertaining to flood plain. Brian asks the Board to approve the application for Feed pad area and access road.
   Angela Gragg made a motion to approve the application for Charles Norris. Al Childers seconded; all were in favor.
- Billy Jo Main/ Paul Gragg (lessee) ACSP
   Angela Gragg recused herself from voting on anything pertaining to this application or Paul Gragg.

The application is for well, livestock watering system, livestock exclusion.

Rob Hunt made a motion to approve the application for Billie Jo Main/ Paul Gragg. Al Childers seconded; all were in favor. Rob Baldwin reminded Board that contract will have to be approved by the Commission.

Robina Walker- ACSP she is a vet from Charlotte. She turned in an application for Christmas tree
removal. However Brian went out and discussed the program with her and found out she is not
eligible because she is a new land owner. So this application is null and void.

CCAP- Board of Education is waiting on the Division to approve the design. Brian has a meeting September 1, 2015 with principle, grounds keeper and Connor Boyle with Brushy Fork Environmental on what needs to be done and in what order. Kids will be participating with the project Horticulture, Construction and Mountain Alliance group. Daphne Cartner has everything she needs. Angela Gragg advised Brian to speak with Connor Boyle, PE with Brushy Fork Environmental and make sure he puts his Engineers seal on the design.

Wendy Patoprsty our Extension Agent along with Watauga River Keepers received a 319 grant for Beaver Dam Impaired & Impacted watershed. Soil & Water will be partnering with them. Brian will keep the Board informed.

CET – Brian informed the Board the training was good he had enjoyed it and felt it was very helpful.

Bird Flu- If you have chickens you need to register. It is voluntary and can be done online the process is very simple.

Pasture Forage- There will be a Field Day on September 15, 2015. Brian is unable to attend due to scheduled presentation.

Soil Health Team- Brian told the Board they are in the process of planning a tour to view cover crops in PA and VA. Brian was worried that he would have to pay for it out of pocket. The dates have not been decided yet, but Brian wanted to get approval from the Board because of the time it takes to get out of state approval on travel.

Angela Gragg made a motion for the Board to approve the out of state travel for Brian to participate in the Soil Health Team tour and for it to be added to the Commissioners agenda. Joey Clawson seconded all were in favor.

David Tucker – NRCS gave handouts introducing the New Service Delivery Model. Watauga is part of Team 3. David discussed the plan and how they want it to work. Fred Alexander has tenure and so he will have the opportunity to become the supervisor for the team if he should turn it down the opportunity for Supervisor would go to David Tucker.
