## **New Applications**

He is also applying for EQIP for assistance. Board discussed.

#### **ASCP**

- Billy Kennedy 95-2015-008- RFP has been submitted for approval.
- Al Zimmerman 95-2015-006- Road is almost finished waiting on the weather to improve.
- Victor Fortune 95-2017-003- Board voted to approve his contract for \$11,826 for fence, well, pump, pipeline, and tank.
  - Joey Clawson made a motion to approve the contract # 95-2017-003 for Victor Fortune in the amount of \$11,826. Rob Hunt seconded; all were in favor.

Division Report – Rob Baldwin wanted to mention some things to the Board, because he has the Districts best interests in mind. Just like Mr. Goddard with BREC and Charles Anderson with RI are looking out for their best interests.

- If the district accepts any monies from a contractor or other outside sources, they should have a contract agreement stating the responsibilities of all concerned. It should also state when the monies will be received and the expectations of all parties.
- All aspects of these funds should be discussed up front and voted on by the board of supervisors, and the funds the district receives should be referred to as an Administrative Fee.
- If the district is taking on potential responsibility for a project, the district should require the third party to be bonded or the district should secure their own insurance policy to protect the district from a lawsuit in the event of a catastrophic failure.
- The county administration i.e.; county manager and county attorney etc., should be a part of all discussions in regards to any and all funds coming into the district.

Rob Baldwin asks the Board if they have any question about any of the information. None was noted.

## **AgWRAP**

 Gerald Haas -contract # 95-2017-801 Isaac Hodges ask the Board to do a revision to the contract amount, originally it was for \$2,000. It needs to be revised to \$3,000.
