Denny Norris called the meeting at 8am
Minutes from January 24, 2018- approved as presented
Agenda for February 28, 2018 – approved as presented
Conflicts Clause was presented- no conflicts were noted

District Report-Isaac Hodges

Isaac Hodges informed the Board he had sent out letters to the 3 active 2016 contracts that will expire June 30 of 2018. He wanted to remind them of the deadline.

- Shelena Helms 95-2017-004 ACSP- They are 90% finished, waiting on the weather to do filter cloth and gravel.
- Gerald Haas 95-2017-801 AgWrap- Tom Hill advised Isaac Hodges to cancel the funds because they cannot locate the well.
 - Joey Clawson made a motion to cancel the AgWrap contract # 95-2017-801 for Gerald Haas in the amount of \$3000 for a pump. Rob Hunt seconded; all were in favor.
- Hardin Park 95-2016-501 CCAP- Isaac Hodges asks the Board to cancel the funds for this
 contract. Hardin Park could not meet the Division Engineers plans. Isaac Hodges pun in a
 request for technical assistance in December of 2016. He received a reply February 16, 2018
 from Daphne Cartner about the engineering of the project. Isaac informed Daphne the project
 has already been constructed due to the fact they could not meet the engineering
 requirements.

Joey Clawson made a motion to cancel the funds for CCAP Hardin Park 95-2016-501 in the amount of \$ 4,198.00. Todd Combs seconded; all were in favor

Approval of contracts (ACSP)

- 95-2018-004 Scott and Barbara James Isaac Hodges presented the Board with a revision on this contract. The owners are requesting to scale back the project and fence out the stream and use a spring instead of digging a well.
 - Al Childers made a motion to revise the bmp's and the contract amount to \$12,447 for contract # 95-2018-004 for Scott & Barbara James. Todd Combs seconded; all were in favor.
- Jeff Brown 95-2018-005 is requesting funding for ag road repair and conservation cover.

Isaac Hodges explained to the Board about how this contract ranked against Paul Gragg's Vanderpool road application. The Paul Gragg application is very high ranking and will require more funding. Both the landowner and Paul Gragg were in agreement to wait until the next funding cycle to submit another application in order to keep the entire contract within one physical year and not have to do supplement contracts because they are so confusing.

Joey Clawson made a motion to approve Jeff Brown 95-2018-005 in the amount of \$11,547. Al Childers seconded; all were in favor.
