**District Report - Isaac Hodges** 

New Applications – Doug Carson AgWRAP applicant. Mr. Carson is in need of a well and pump. He has water quantity issues.

Doug Carson contract # 95-2019-801 AgWRAP \$7,500 for a well and pump. This is the only application we received for this program.

Bill Moretz made a motion to approve the contract for Doug Carson 95-2019-801 for a well and pump in the amount of \$7,500. Jimmy South seconded; all were in favor.

Valle Crucis CCAP 95-2019-501 design was received after last SWCD meeting. Todd Combs made a motion to approve CCAP contract #95-2019-501 for Valle Crucis Park \$7,546. Bill Moretz seconded; all were in favor.

David Stephens 95-2018-005 starting project in April/May he has paired with NRCS funding also.

Jeff Brown 95-2018-005- done with access road. Will be applying filter cloth and gravel next.

Matthew Duval 95-2019-005 He has started purchasing his supplies needed for the contracted BMP's.

Charles Norris 95-2016-002 Isaac Hodges met with Mr. Norris to discuss a catch basin, due to the way water is running off. It is not a contracted catch basin. If Mr. Norris installs the catch basin it would

take care of the issue. He has the equipment to maintain and keep it cleaned out. Heavy use area is complete and he should be done with the project by June 30, 2019 deadline.

Bob Shipley 95-2019-004 - A letter was sent out from the Board letting Mr. Shipley know he was out of compliance.
