StRAP Updates:

2022 Funds: Vegetative Debris only. Mikey Woodie asked the board to be able to work with Emergency Management Director, Will Holt (Friday, November 1, 2024) to coordinate to find areas where the debris is the worst and Soil & Water could get these projects completed quicker than the County. She asked Deron Geouque, Watauga County Manager and was granted, permission to conduct debris removal projects under \$15,000 without the need to put them out for bidding. Mikey Woodie requested to use Hicks Construction Enterprises as the contractor of these projects if they are available and can do them quickly. They did the best work on our previous projects and were easy to work with. Jennie Hanifan made a motion to allow Ms. Woodie to work with Emergency Services to find small projects that will make the biggest impact and to use her discretion to hire a contractor to complete these projects. Todd Combs 2nd the motion. Motion carried.

2024 Funds: Watauga County Commissioners approved the contract.

NRCS Report – David Tucker

Tucker stated that there will be extended signups for ESP. There will need to be repairs on existing contracts.

There were 700 landslides in NC due to Hurricane Helene.

There will be trainings coming in Wilkes and Lenoir. Details to follow.

The Elk Creek project was destroyed in hurricane.

Catepillar donated machines and labor to help with the landslides. ECP doesn't cover land slides. It only covers debris in fields.
